## **FREQUENTLY ASKED QUESTIONS**

## Can I have a pistol in the car while picking up kids at school?

If you have a permit, yes. The "Gun Free School Zone Act" exempts permit holders as long as your permit is issued in the state where you are in the school zone.

## Can I carry in a vehicle without a permit?

Yes! Alabama Law recently changed to allow a Law Abiding Citizen to carry a loaded pistol in their vehicle **But not in a school zone.** Federal law requires an Alabama permit to be within 1,000 feet of a school.

## Where am I not allowed to carry a weapon?

Federal facilities (except Federal parks), a court house/annex, police stations, sheriff's office, district attorneys office, and a few more. See BamaCarry.us for the entire code reference.

## What is the legal age to carry?

The legal age in Alabama is 19 for both open and concealed Carry.

## Can I consume alcohol when armed?

There is no law concerning alcohol and carrying a pistol. However, it is a bad idea and never advised.

## Can I carry into a business such as Lowe's, Wal-Mart or a convenience store?

Large businesses like Lowe's and Wal-Mart typically follow state law. Signs in Alabama do not carry the weight of law, but you can be asked to leave.

# Do I have to give the serial number of my gun when I apply for a permit?

NO! This is a form of registration and it's illegal for you to be asked.

## **OPEN vs CONCEALED CARRY**

BamaCarry takes no stance on pushing one form of carry over the other. Both are perfectly legal. It was during Alabama's civil rights era that lawmakers made carrying a firearm, in a vehicle illegal without first obtaining a Govt permission slip. Open carry has been legal since before the formation of our State.

Both forms of carry have their place in society. There are opinions to support the effectiveness and downfalls of both carry methods. However, BamaCarry stands up for and defends all legal ways of carry.

## **CONCEALED HANDGUN PERMITS**

Several Gun Rights Groups worked together to make Alabama fall more in line with the Constitution. BamaCarry pulled the plow in the end and made it happen. Permits are no longer

### required in Alabama.

In 2013, new laws also went into effect limiting the criteria a sheriff could use in order to deny a permit. This was a big step in reversal of a law that has served to oppress, discriminate, and intimidate the people of Alabama into political submission by some sheriffs. If you are denied a permit the Sheriff is required to give you a reason in writing. If you don't agree, you can take the decision to a judge and plead your case. If a decision is made that you should have a permit then one shall be issued to you.
